

# **French photovoltaic energy storage project planning scheme**





## Overview

---

Will a solar power plant in France be sold through PPAs?

The electricity generated by the plant will be sold through PPAs to unspecified customers. French energy giant Engie and France-based independent power producer Neoen have announced a plan to build Europe's largest solar-plus-storage plant near Saucats, a municipality in the Gironde department in Nouvelle-Aquitaine in southwestern France.

What are France's photovoltaic policies?

France's photovoltaic (PV) policies are developed within the National Low Carbon Strategy and the Energy Programme Decree. The current Energy Programme Decree aims for 20 GW of PV capacity by 2023, rising to 35-44 GW by 2028.

Why is solar PV mandatory in France?

Mandatory solar: Solar PV is mandatory for living roofs for commercial and industrial buildings or covered car parks occupying 500 m<sup>2</sup> or more of ground surface. Power to the people: France's current policy framework is supportive of collective self-consumption and energy communities, with flexible regulations supporting prosumers.

Is TotalEnergies the biggest battery storage project in France?

The energy major has 103MW of capacity market contracted energy storage online or coming online in France. Interestingly however, despite presiding over the single biggest project in the country, TotalEnergies sits second in Clean Horizon's chart of France's most prolific (publicly announced) battery storage project owners and developers.

What percentage of French electricity comes from wind and solar?

As a result of the development of renewable energy in 2023, wind and solar installations represented 14.6% of the French electricity mix. Wind power



became the third-largest generator, behind nuclear and hydro power but ahead of gas.

What is tagenergy doing in France?

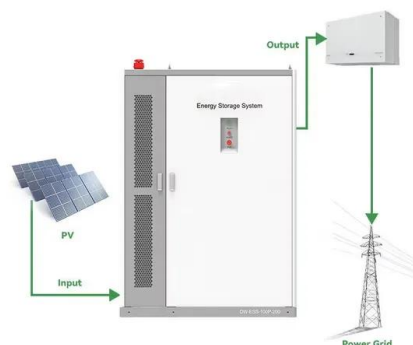
