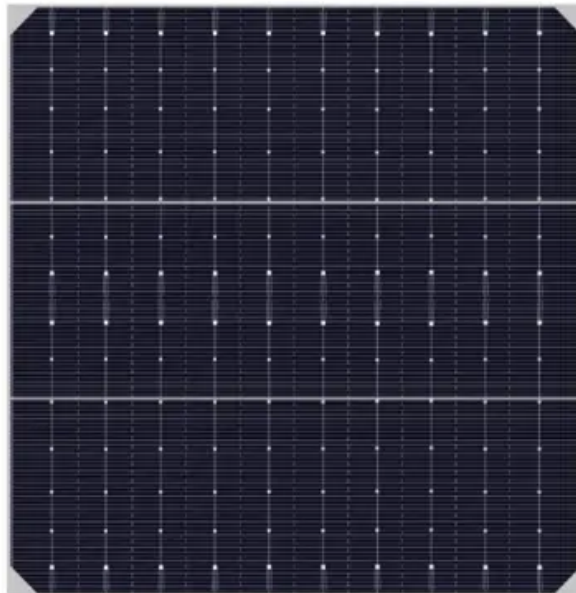


Government pays for solar photovoltaic panels

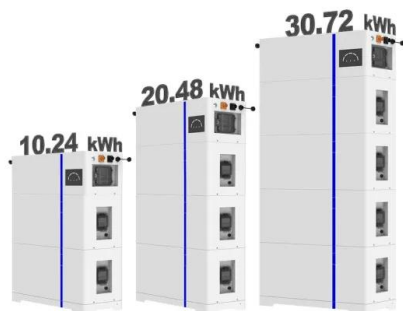
