

# **Latest in French solar panels**







#### **Overview**

These compact solar kits can be plugged directly into a home socket and begin producing electricity without professional installation. But starting August 23, 2025, France may prohibit their use entirely, sparking criticism from both solar advocates and energy experts. Are solar panels a good investment in France?

As electricity prices continue to soar in France - up 60% in four years - more people are turning towards solar panel kits, which promise to help users save on energy costs and installation prices. The estimated extra cost of electricity in 2024, compared to 2020, is €540 per household per year.

Should you install solar panels in France?

Installing solar panels in France is a promising solution for reducing electricity costs and contributing to environmental sustainability. However, before starting, it is important to review legal aspects, obtain the necessary permits, and take advantage of government subsidies.

How many solar panels did France install in 2023?

From pv magazine France France deployed around 921 MW of new PV systems in the fourth quarter of 2023, according to new figures released by French grid operator Enedis. For all of 2023, the country added 3,135 MW of new solar capacity. The results represent a 30% increase from 2022, when around 2.6 GW of solar was installed.

What is the VAT rate for solar panels in France?

A reduced VAT rate of 10% instead of the standard 20% applies to solar panel installations in France. This measure is available for residential properties used as primary homes. Many regions in France offer additional subsidies for solar panel installations. These initiatives can significantly lower initial costs.

Does France offer interest-free loans for solar panels?



In some cases, the installation may be prohibited or require specific solutions to minimize visual impact. France offers an interest-free loan (Eco-PTZ) to finance solar panel installation projects. This measure helps homeowners reduce financial burdens without paying interest.

Does France offer subsidies for solar panels?

Many regions in France offer additional subsidies for solar panel installations. These initiatives can significantly lower initial costs. To qualify for government subsidies, it is recommended to hire certified professionals with the RGE (Reconnu Garant de l'Environnement) license.
