

Latvia exempts bifacial photovoltaic modules





Overview

Are bifacial solar modules exempt from Section 201 tariffs?

Bifacial solar modules have lost their exemption from the Section 201 tariffs on imported solar panels, effective May 18, 2020. A review: All imported solar panels were taxed beginning in 2018.

Are CSPV bifacial modules exempt from Section 201 tariff?

CSPV bifacial modules are currently exempt from the Section 201 tariff. Since most modules today are bifacial, the Section 201 tariff does not cover most module imports. On May 16, 2024, however, President Biden announced that he will soon rescind the bifacial panel exemption.

Why are bifacial panels exempt from tariffs?

Bifacial panels were originally exempt from the tariffs because there was no significant domestic manufacturing capacity of the specialty product. This caused more bifacial modules to be imported into the United States than monofacial panels, undermining the objectives of the original safeguard measure.

When did the tariff exemption for bifacial modules expire?

The U.S. Court of International Trade (CIT) stepped in and reinstated the exemption for bifacial modules in December 2019. The U.S. Trade Representative (USTR) accepted public comments on the bifacial exemption through February 2020. And now, in April 2020, the USTR again removed the tariff exemption for bifacial modules.

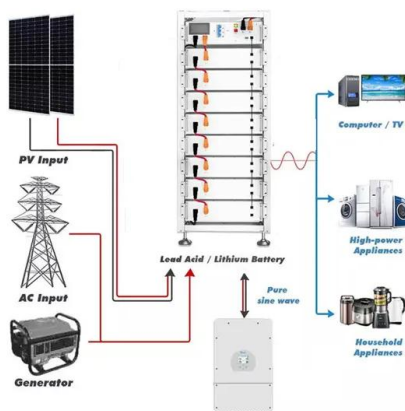
